#### **Hazard and Precautionary Information:**

#### Hazard Statements:

Flammable liquid and vapour. Harmful if swallowed. Harmful if inhaled. Causes mild skin irritation. Causes eye irritation. May cause an allergic skin reaction. # 4. FIRST AID MEASURES

#### Inhalation:

Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. If patient finds breathing difficult and develops a bluish discolouration of the skin (which suggests a lack of oxygen in the blood - cyanosis), ensure airways are clear of any obstruction and have a qualified person give oxygen through a face mask. Apply artificial respiration if patient is not breathing. Seek immediate medical advice.

#### **Skin Contact:**

If skin or hair contact occurs, immediately remove any contaminated clothing and wash skin and hair thoroughly with running water. A component of this material can be absorbed through the skin with resultant toxic effects. Seek immediate medical assistance.

# 5. FIRE FIGHTING MEASURES

# 6. ACCIDENTAL RELEASE MEASURES

### Methods and materials for containment and clean up:

Shut off all possible sources of ignition. Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal.

## 7. HANDLING AND STORAGE

**Precautions for safe handling:** Avoid skin and eye contact and breathing in vapour. May form flammable vapour mixtures with air. All potential sources of ignition (open flames, pilot lights, furnaces, spark producing switches and electrical equipment etc) must be eliminated both in and near the work area. Do NOT smoke. WES - TWA (Workplace Exposure Standard - Time Weighted Average) - The eight-hour, time-weighted average exposure standard is designed to protect the worker from the effects of long-term exposure.

WES - STEL (Workplace Exposure Standard - Short Term Exposure Limits) - The 15 minute average exposure standard. Applies to any 15 minute period in the working day and is designed to protect the worker against adverse effects of irritation, chronic or irreversible tissue change, or narcosis that may increase the likelihood of accidents. The WES-STEL is not an alternative to the WES-TWA; both short-term and eight-hour, time-weighted average exposures should be determined.

# 11. TOXICOLOGICAL INFORMATION
